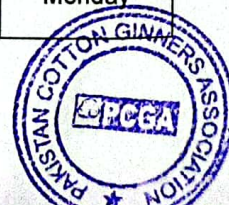


PAKISTAN COTTON GINNERS' ASSOCIATION (PCGA)
