RULES FOR 2026-2028 GENERAL ELECTIONS

In exercise of the powers vested under Article and Memorandum of PCGA, the Central Executive Committee of PCGA in its 331st meeting held on 11.07.2026 has approved and adopted the following Election Rules for 2026-2028 and set forth the dates (Election Schedule) on which the elections of the both Zones and that Annual General Body Meeting of PCGA should be held for the year 2026-2028. All timings shall be working hours of the Association Office i.e. 09:30 am to 05.30 pm for the following scheduled program, except shown otherwise.

RULES AND DATE WISE SCHEDULE FOR 2024-2026 GENERAL ELECTIONS

RESOLVED that General Elections for 2026-2028 shall be governed by the following Rules:-

1. Election Commission has been constituted comprising upon three (03) members (i) **Mr. Mukesh Kumar [Madan Lal]** (Election Commissioner) (ii) **Haji Muhammad Afzal** (Member) and **Mr. Muhammad Khubaib Ali Waigel Rehmani** (Member). The Election Commission shall examine the eligibility of membership on appeals/complaints and shall scrutinize the nomination papers and shall supervise the whole process of elections right from announcement of election schedule upto the completion of election results. Mr. Zakirullah Khalidi, Secretary General will be the Returning Officer whereas Mr. Muhammad Umer Farooq Malik, Deputy Secretary will be the Deputy Returning Officer and Mr. Aqeel Haider, Social Media Coordinator will be the Assistant Returning Officer. Mirza Taufique Baig, Assistant Secretary and Mr. Muhammad Basit, Assistant of PCGA South Zone will be the Assistant Returning Officers. In case any candidate is not satisfied with the decision of the Election Commission, he may file his appeal to the same Committee on concrete and solid grounds for reconsideration. However, the decision of the Committee or reconsideration request shall be final, binding and not challengeable. In case of some unavoidable circumstances of Mr. Zakirullah Khalidi, Secretary General/Returning Officer, Mr. Muhammad Umer Farooq Malik, Deputy Secretary/Deputy Returning Officer may work as Returning Officer under delegated powers.
2. In case no nominations are received or there are lesser number of nominations then the number of seats are filled from any zone, by the General Body in its Annual General Body meeting amongst in its full fledged members, any person (s) as its representative on the Executive Committee for two years from 2026-2028. All members of the Central Executive Committee and Office bearers shall stand retired on 30.09.2024 after handing over the charge to the next elected members of the Central Executive Committee and Office bearers.
3. Mr. Zakirullah Khalidi, Secretary General/Returning Officer will conduct the election in both the Zones whereas Mr. Muhammad Umer Malik, Deputy Secretary will be the Deputy Returning Office and Mr. Aqeel Haider, Social Media Coordinator will be the Assistant Returning Officer and shall conduct the elections of the North Zone. Mirza. Taufique Baig, Assistant Secretary and Mr. Muhammad Basit, Assistant will be the Assistant Returning Officer of South Zone who shall conduct the election of South Zone.
4. The agenda of the Annual General Body Meeting of PCGA shall be issued on 05.09.2026 along with the notices of Annual General Body Meeting. The Annual General Body Meeting of PCGA shall be held on 26.09.2026 at 02.00 p.m at Multan.



5. NOMINATIONS FOR THE MEMBERS OF EXECUTIVE COMMITTEE RECEIVED AFTER THE DUE DATE VIZ 26.08.26 OR WITHOUT PRESCRIBED FEE AS STATED UNDER RULE OF ELECTION MAY BE DEEMED AS INVALID.
6. Only such members whose names appear in the Electoral Roll 2026-2028 and the Corrigendum thereof shall be eligible to vote or stand for election or nominate as candidate for election and also exercise all such entitlements as are required for the General Elections of PCGA.
7. Only the official forms of nominations for the Executive Committee, Chairman, Senior Vice-Chairman and Vice Chairmen elections appended herewith shall be used for filing the nominations. Any other form or wrongly filled or containing corrections, alterations or mutilated form sent, shall be deemed to be invalid. Official Form typed neatly on plane papers or a clear photocopy thereof shall be acceptable.
8. Nomination Form(s) may be sent by Registered Post duly addressed to the Returning Officer, Pakistan Cotton Ginners' Association, PCGA House, MDA Road, Multan so as to reach him for Executive Committee Member on or before 26.08.2026 upto 4:00 pm and for Chairman, Senior Vice Chairman and Vice Chairman on or before 17.09.2026 up to 4:00 pm. Nominations sent to any other official or office bearers or received after 4:00 pm on both of the respective dates shall be deemed to be invalid. Hand delivery of nominations shall be accepted by the Returning Officer according to the above mentioned schedule up to 4:00 pm.
9. Every candidate will have to declare that he along with his Proposer and Secunder are not the defaulter of PCGA in any manner. In case any of them is found defaulter and any recovery is pointed out against any one of them even at lateral stage the candidate shall be liable to be expelled from the seat he shall hold in the result of these elections. However if recovery is guaranteed to be deposited the case may be relaxed.
10. The withdrawal of nominations shall be only by the personal appearance of the candidate before the Returning Officer. The withdrawal on fax, through DAK or through any other person shall be accepted subject to the approval of Election Commission constituted under the Rules. The name once withdrawn shall not be allowed to re-contest in any case.
11. If any vote is disputed on the day of Election the decision of the Election Commission shall be final.
12. Every candidate will be allowed to nominate his representative on the polling by a written request to the Returning Officer but the polling representative must be an "eligible voter" and belongs to respective zone of the candidate from where he is contesting.
13. The representative of candidates will not be allowed to make any canvassing at the place of polling booth. Any representative found doing so shall be liable to be relieved off by the Returning Officer.
14. Notwithstanding anything contained in these election rules, the election and meetings shall be conducted in confirming with the procedure laid down in the Approved Memorandum & Articles of Pakistan Cotton Ginners' Association and in according to the Trade Organization Rules, 2013.
15. The election will be held for 30 seats of Central Executive Committee and office bearers in place of outgoing members and office bearers. The list of sitting office bearers and members of Central Executive Committee of PCGA are as follow:-

Any nomination form filed without the above prescribed fee will not be accepted/entertained.

Nominations sent by ordinary post or addressed to any other official or office bearers or received after prescribed time both of the above respective dates shall be deemed to be invalid. Hand delivery will also be accepted by the Returning Officer according to above mentioned schedule.

Only authorized representatives whose names appear in the said Electoral Rolls shall propose or second a candidate and or/ be proposed and seconded to contest for any post. Valid payment document for the portfolio applied (prescribed fee as circulated in said Election Rules for 2026-2028 must be attached with the Nomination Form) failing which nomination form shall be deemed invalid. Only those names have been included in the Official Electoral Roll who were bonafied members in the last year and have also paid Annual Subscription of the Association upto 20.04.2026.
